This form will cover permission for your child/ward throughout their school life at Amano Christian School. You may request to update it at any time but you will be asked to update it when your child/ward begins Grade 8.

1. I hereby undertake to pay punctually and in full, any fees and expenses that are incurred. I acknowledge that I am personally liable to pay such fees and expenses.
2. I undertake to give a term's notice before the removal of my child/ward, or to pay one term's fees in lieu. Such notices will be in writing, signed by myself and delivered to the Administrator in order to be valid and binding.
3. I undertake to make every effort to ensure that my child/ward will not be absent from school without leave of absence being granted by the school (excepting absences due to medical reasons), and that the term dates will be strictly adhered to.
4. I undertake to support any decision made by the Administration regarding discipline or expulsion of my child/ward. My child/ward understands this and agrees to abide by the rules as stated by the School.
5. I undertake to support the Christian philosophy of the school and agree to my child/ward taking part in the Christian activities of the school, realising that my child/ward may decide to become a committed Christian while at Amano Christian School.
6. I hereby give my consent for the School Administration to decide what medical care or treatment is necessary for my child/ward and to sign on my behalf for such treatment or care, whenever my child/ward is participating in activities arranged by the School.
7. I hereby give consent for the school to take photographs of my child/ward whilst they are involved in school activities. I understand that these photographs will only be used for school purposes such as publication on the website, advertising literature and presentations that staff, or their sending organisation, may use to publicise the work of the school. All pictures will remain copyrighted to Amano Christian School and should not be used, copied or printed without written permission from the school's Administrative Director.
8. I hereby give my consent for my child/ward to take part in all activities of the school including, among other things, games, sports, educational tours and excursions of any nature whatsoever, provided they have been properly authorised by the Administrator. I fully understand and accept that all such activities are undertaken at the sole risk of my child/ward and on his or her behalf and for myself, my estate and my wife/husband, I do hereby indemnify, hold harmless and absolve, the School Board of Governors, the Administrator and the staff against and from any or all claims whatsoever in connection with any injury to my child/ward or loss of or damage to property arising from the pursuit of the aforesaid activities. This is in the knowledge that the Administrator and the staff will nevertheless, take all reasonable precautions for the safety and welfare of my child/ward.
